DURHAM CONSERVATION COMMISSION Minutes to Meeting - Final 10 February 2005

Meeting called to order at 7:05pm

1. New Business/Presentations

a. Mark Zankel (Nature Conservancy) - <u>Follett's Brook Watershed Ecological Inventory</u>

- Mr. Zankel gave a PP presentation (a copy provided to Lee Alexander) on the results of the habitat inventory/assessment. Two copies of the written report were provided. One copy will be kept in Town Hall.

6 Steps to the Inventory

- 1. landscape analysis
- 2. landownership
- 3. compile existing info
- 4. conduct field inventory
- 5. compile/analyze field data
- 6. develop conservation plans

Dea Brickner Wood - (Gt. Bay Protection) explained the Follett's Brook study and funding request of \$5K from DCC for appraisal (to be appropriated if the project is approved).

- Will apply for N.Am Wetland Conservation Act (NACA) grant. They want Durham to be a partner along with Newmarket. This could lead to 2:1 matching for land conservation. Peter Smith mentioned the importance of the Land Protection WG being involved in this effort.

- \$5K expenditure was approved (all in favor), to be taken out of Conservation Fund Current Use penalty tax account.

b. Jack Farrell - Craig Meadows development

Mr. Farrell presented a new concept plan for a senior housing complex off Madbury Road (5 acres). The plan includes the set aside of a large conservation area (12.5 acres). DCC felt that this appears to be an improved concept compared to what had been previously proposed. It also addresses many of the concerns provided in a Memorandum from DCC to the Planning Commission (11 Dec 02). If this project is approved, Duane Hyde suggested that the Strafford Rivers Conservancy could hold the conservation easement.

Duane briefly reviewed the content of his Memo to DCC (8 Feb 05). For the 21.5 acre parcel, Tom Merrick (owner) is willing to grant a conservation easement for \$75,000. Additional acquisition funds needed would be approximately \$15,000. Most likely, the Easement would go the Strafford Rivers Conservancy or be held by the town with conservation easement/stewardship contracted to a Land Trust.

Tom Merrick provided a brief history and overview of the property, and conveyed his interest in seeing the property conserved.

\$75,000 (Conservation Easement)

<u>15,000</u> (acquisition fees)

\$90,000

\$90K approved (all in favor) - to be taken out of Current Use penalty tax

2) <u>Funding request for land appraisal</u>

60 acre tract of land (primary scenic vista). Estimated to be \$5,000.

\$5K was approved (all in favor) – funds to come out of conservation fund
