June 9, 2005

Chairman, Dwight Baldwin, introduced Richard Ozenich, the Planning Board's new representative to the DCC.

1. New Business/Presentations

a. Management of Beards Pond

Harold Hocker gave a brief overview of the history of Beards Pond and stated that the homeowners whose properties abut Beards Pond would like: 1. the DCC to appoint a subcommittee to work with the Beards Pond group to provide advice on how to manage the pond - 2. a legal opinion from the town as to who owns the land under the pond (Mr. Hocker stated that the DCC gave a <u>verbal</u> legal opinion on 10/14/98 that the abutters own the land on the bottom of the pond.) Several abutters stated that their property deeds include land to the original Beards Creek, -3. to know what is the legal water level? Harold Hocker will phone Mike Lynch to see if Durham or NHDOT recently installed a flash board at the dam that raised the water level about one foot.

b. Gene A. Auty Property 32 Colony Cove Road, Durham

Adele Fiorillo, NH Soil Consultants, Inc., and Roberta Woodburn, Woodburn and Company, presented the following plan for the above property:

- remove an existing cottage (within the tidal buffer zone)
- move on existing garage (currently outside the tidal buffer zone) to the current location of the cottage
- build a new deck, connecting the garage to the existing residence
- rebuild a retaining wall to stabilize the upland bank
- replace existing septic

The Standard Dredge and Fill Application was signed by the Durham deputy town clerk on 5/19/05. The application has to be amended (to include replacing the septic tank.)

Discussion re: pervious vs. impervious surface, sea wall construction, setbacks c. <u>Richard Horan Property</u> 14 Riverview Road, Durham

- Roberta Woodburn, Woodburn and Company, presented a plan that included:
 - removal of 7 large trees (property is approximately 75% wooded)
 - replace grass along river with low growth native bushes (25 foot buffer)
 - replace existing lawn with new lawn (within 75'zone)

Peter Smith stated he would be against the removal of any large, live trees DCC plans a site visit 6/14/05 at 5:00pm

d. Assessment of Oyster River Volunteer Monitoring Data

Tom Lee, Oyster River Watershed Association (ORWA), gave a power point presentation that summarized the 2001, 2002, and 2003 data recorded at 14 sample sites. The Oyster River Watershed covers 6 towns. Twenty four variables were measured. Funding comes from grants and UNH. The following practical application of the study was mentioned: a very poor water quality was noted at one sampling site, the problem was traced to the Durham Industrial Park, Durham engineer notified and problem was resolved. Brian Gallagher, ORWA, also discussed issues and answered questions.
