Andrea moved to amend the Agenda to hear the presentation of the GRANGE HALL RFP by Peter Murphy (GrangeHall Lofts, 6 Newbury St, Newburyport Ma). Seconded by the Peter Wolfe.

A. GRANGE

Grange Hall Lofts (GHL, LLC) proposes a historic renovation to the current structure located on Main St, Durham by developing two luxury student apartments and a 1200sf commercial/retail space on the first floor. GHL would invest \$275,000 for this historic renovation and build out. The project would house 12-13 students and fill a new for newly renovate, state of the art, off campus housing the in the downtown area as well as offer new retail space.

GHL, LLC proposed two options – one for a 15 yr lease (three 5 year options) and the other for a purchase price. Both options would preserve the existing paved walking path that connects the Mill Plaza and Main St.

After discussion, it is the consensus of the HDC to support the concept of moving the Grange building forward to the street line to maintain the streetscape. The HDC does not approve of the addition of a porch to the facade. Peter Stanhope moved that HDC accept this motion, Crawford seconded the motion. Motion accepted/carried
