B. Should DEC be open to nonresident membership? TheCommittee believes that all expertise is welcome, so the answer is "yes."

C. Whether to pursue through our state legislators the possibility of municipal funding for homeowner energy efficiency measures? A bill about this is in the wings. Laurel reported that Dorn Cox of the Lee Energy Committee says there are some good measures in this bill. Follow-up: research this bill specifically and learn how we can find out about energy-related legislation in general. (MEAP - Municipal Energy Assistance Program is the title. Look at LEC web site for this.) Kevin will ask Representative Amanda Merrill to attend a meeting.

D.The Energy Committee applied for NH Office of Energy and Planning Retrofit Ramp-Up Program - they were looking for a few towns to work with on a very short time frame to put in the proposal for rapid implementation of GHG-saving measures. Laurel reported that Dorn of the Lee Energy committee says there are some good measures in this bill. (Look for this on web!). Look at LEC web site for MEAP -Municipal Energy Assistance Program.

- E. NH Municipal Energy Committee "Energy Efficiency Block Grant Program." We need to follow up.
- F. Energy audits for municipal facilities, equipment and operating practices. There have been some assessments done already, by PSNH (our recollection is that it looked only at the electrical systems) and Ihab Farag had a class of student evaluate the Town Public Works site.
- G. Kevin will draft: 1) Town energy policy for buildings 2) Vehicles etc.
- H. Dave noted that the application to the Bicycle Friendly Community program was rejected, but that Durham will reapply next year: additional developments in Durham will help.

## **Mike:** We need bike racks as tradeoff with required parking spaces. Options?? Business??

I. Laurel: SPC - Strafford Regional Planning Commission has programs to consider.
