B. Correspondence

- 2. Bee-Friendly Program Lee Alexander reported that he has started compiling the annual recertification process for BeeCity USA. Hopefully, the process will be less complicated than last year.
- 3. Food Friendly Yards Ellen Karelitz and Bryan Cassidy reported that six e-mail sessions have been posted, with two more to come. There will be a meeting at the Town Library on 12 March to share ideas.
- 4. Durham Farm Day Scheduled for 15 August 2020. Alberto Manalo will contact UNH COLSA as to the best POC for demo at Woodman Farm Agricultural Experiment Station. Ellen suggested that Farm Day is an opportunity to conduct hands on demonstrations associated with the new Agricultural Zoning ordinance. Developing a PP Pres and website are also a possibility.

 - E. Land Stewardship Subcommittee John Carroll reported that "trails" is currently the main focus.
