Meeting Minutes Durham Agricultural Commission April 10, 2023

I. New Business

A. Conservation with COLSA students – We were joined by one student, Dylan File, a junior, interested in sustainability and environmental policy. Ag Comm members explained the purpose and role of the agricultural commissions in New Hampshire and described Ag Comm projects. Bekkerman asked Dylan to suggest topics of concern. He replied that he lives at the Lodges and there is no recycling program for residents. Rasmussen said the landlords will be more inclined to provide recycling services if the tenants ask for it.

- B. Minutes of the March Meeting Winans moved to accept the minutes of the March meeting LaRoche seconded the motion. The motion passed with Cassidy abstaining.
- C. Comments on the Master Plan Climate Action Chapter Langley recommended adding goal statements regarding encouraging individuals growing food and encouraging neighborhood scale and collaborative agriculture. Bekkerman recommended adding a goal statement regarding reviewing existing conservation easements to identify opportunities for agriculture. Walker will submit these edits to Michael Behrendt.
- D. Earth Day Langley said he and Karelitz are pulling together several activities to offer at the town's Earth Day event, including planting lettuce seeds in a cup, a no-dig garden bed demo, the Oyster River foodshed map, and more. He has also purchased children's coloring book about do dig gardening to giveaway.

II. Old Business

A. Ag Comm Initiatives

- Redefining agricultural activity Langley met with Audrey Cline to discuss her use of the
 livestock stocking spreadsheet. Cline supports this project. Walker and Langley will put together
 a demonstration of the spreadsheet as applied to several neighborhoods in Durham. LaRoche
 asked if horses would be allowed downtown. Langley replied the spreadsheet could block horses
 from being housed in the RA and RB zones. Bekkerman suggested adding manure management
 to the spreadsheet. Cassidy said different types of land exist in every zone and we need to leave
 room for possibility.
- Bee Friendly Program Walker read a report from Alexander saying he will be helping the
 Wagon Hill Farm community garden with bees and a hive as last year's beekeeper cannot. He has
 met with the Conservation Commission and Land Stewardship Subcommittee about sharing the
 management of the Xerces Society/Bee City USA program
- Garden and Farm Mentors Cassidy said he is thinking about offering a broom making workshop.
