RE: 2019 Proposed Budget Narrative

Dear Todd,

I am pleased to submit a 2019 budget for the building inspection/zoning enforcement/public health department with a proposed overall increase from 2018 of just 2%. We have no large individual adjustments from the 2018 approved budget, but a number of small changes in the projected department needs.

With the experience of the part-time Zoning Enforcement Officer position funded in 2018, we recognize an increase in several line items: training, travel, cell phone, and legal costs (certified mailings and Sheriff's service). Also we have included an amount for training, travel and membership to the Building Officials Support Staff (BOSS) for our administrative assistant. The ability to attend meetings and trainings help keep our staff engaged and invested in their work for the Citizens of Durham.

We have included two items for purchase. A large format scanner will allow us to electronically store any material that is submitted hardcopy, as well as allow us to continue to scan historic files for the purpose of eventually reducing the footprint of paper storage, which will in turn reduce the off-site storage fees. And somehow perversely, we are presently in need of an additional filing cabinet.

As with 2018, additional inspection time will be necessary to stay abreast of the RiverWoods construction and any other major project that may come forward during 2019. I am proposing that the wages for the part-time inspectors remain at the level funded in 2018, particularly now that RiverWoods is in full-swing. Increased inspection costs are ultimately covered by the building permit fees assessed.
