## ALCOHOL ESTABLISHMENT OPERATIONS AND DESCRIPTION FORM

(adopted by Resolution #2002-24, dated 11/04/02 and updated 05/14/12)

This form and supporting information shall be completed and provided to the Planning and Zoning Office at least **14 days** prior the appointment date with the New Hampshire Liquor Commission for a liquor license.

The information provided in this form is requested in order to ensure that the Town of Durham has sufficient information so as to provide an informed recommendation to the New Hampshire Liquor Commission with respect to an application for a liquor license. This is the minimum information required. Persons are encouraged to supply additional information as they see fit. Additional pages may be used to answer the questions, as necessary.

The Town will notify all abutters, municipal officials and the Town Council on the existence of the application.

The Town Administrator shall provide a formal written recommendation to the New Hampshire Liquor Commission after considering the input of abutters and municipal officials on behalf of the Town.

**NOTE**: Completion of this form does not eliminate the need for the applicant to apply for other permits, such as occupancy and building permits, required by the Town.
