Gas and Propane Appliance and Piping Installations

Required with Application: Verification of adequate capacity if connecting to existing gas piping; fee

Required Inspections:

Rough Inspection: Inspection of gas piping/tubing and trench as applicable. Pressure test required per NFPA 54 and must be witnessed by an inspector.

Final Inspection: Inspection of the final piping installation including connections to the appliance and supply. Appliance must be connected, supplied with gas, and be fired during the inspection.

Note: These inspections can be combined at the request of the installer so long as all requirements of both inspections can be met during one inspection.

Required at Work Completion: Manufacturer's installation and operating manuals

Reminders: Installation must comply with NFPA 54, 2009 Edition. Do not conceal pipe or backfill pipe trench until confirmation is received from the inspector that the equipment has successfully passed inspection; do not charge any piping with gas until confirmation has been received from the inspector that the piping and equipment has passed inspection; ensure all CSST is properly bonded or grounded per NH State requirements; backfill material must be present during rough inspection (if reusing dirt/soil pulled to create the trench, it must be screened to remove rocks and debris). All buried gas pipe/tubing must be buried with caution tape ~4" above the pipe/tubing. All buried polyethylene pipe must be buried with tracer wire. Tracer wire should not touch the pipe. Exterior gas piping must be painted and wall penetration sealed prior to final inspection. Generators must be connected to gas piping via a listed flexible connector; connector must be installed as straight as possible. If converting from oil, Firematic and emergency switch must be removed.

Propane Tank Installation

Required with Application: fee

Required Inspections: Inspection of tank location and connection to gas piping

<u>Reminders:</u> Installation and location must comply with NFPA 58, 2008 Edition. Tanks must be located >5' from any openings into the building below the level of the top of the tank and >10' from any sources of ignition.

Oil-Fired Appliance Installations

Required with Application: fee

Required Inspections: System inspection and operational test upon completion of install

Required Upon Completion: manufacturer's installation and operation manual

Reminders: Tank, appliance, and piping/tubing must meet the requirements of NFPA 31, 2006 Edition.

Wood Stove Inspections

Required with Application: fee

Required Inspections: completed wood stove inspection prior to use

Required upon Completion: manufacturer's installation and operation manual

<u>Reminders:</u> Wood stove must be installed in accordance with NFPA 211, 2010 Edition. The Durham Fire Department does not conduct chimney inspections. Any questions regarding the integrity of the chimney or lining must be directed to a chimney specialist.

To schedule inspections, please contact the Durham Fire Department at (603) 862-1426. The Durham Fire Department requires 24 hours' notice for inspections but may be able to accommodate shorter notice on a case-by-case basis.

Prior to beginning work, please contact the Town of Durham Code Enforcement Office at (603) 868-8064 to determine if mechanical, electrical, plumbing, or building permits are required for the work being conducted.
