The Durham Falls Dam is the earliest concrete buttress-type or Ambursen dam yet identified in New Hampshire, and is one of seven known examples of the type in intact condition in the state. The current dam was built in 1913 with funds provided by Mrs. Edith Angela Congreve Onderdonk, a local philanthropist, to honor the memory of her step-father, Hamilton Smith, to maintain the beauty of the millpond by which her family chapel and cemetery stood, and also to continue to supply water power to the adjacent Jenkins Mill, which continued in operation for a variety of uses through the early twentieth century. The present dam was built by Daniel Chesley of Durham, a noted stonemason and contractor, who pioneered in the use of concrete in this area. The dam is therefore eligible for the State and National Registers of Historic Places under Criterion A for industry and Criterion C for its significance in engineering.
