
Proposed changes (check all that apply)

Describe proposed changes: Add natural gas service to building for immediate use, potential future use. Immediate need for gas service to supply water heaters for new kitchen, taprooms, dishwashers, sinks, etc. Unitil line runs directly across front lawn inside of the sidewalk. Water heaters will be in the basement of North half of the building closest to Newmarket Road. Request permission to trench simplest, shortest distance across lawn to the 'blank' wall to the left of the main entrance (no windows). Picture of the site attached. Picture of the recently installed gas meter and regulator on the Old Courthouse attached. Piping and equipment can be painted white if desired. Unitil is able to do this work on April 10 if this can be approved.
