# IWMAC Meeting Minutes – DRAFT Durham Town Hall Council Chambers October 1, 2025

Meeting called to order at 8:03.

## Compost Challenge report by Jordan and Elizabeth.

- Nine people have signed up (6 councilors and 2 community members who showed interest). No town hall employees have expressed interest. We would like to have more participants, so we agreed that IWMAC members would take part.
- Steven will explore possibility of getting data from Riverwoods about weight of solid waste vs. compost. This could be communicated separately but alongside results of challenge.

# **DPW Update**. Sam and Rich absent.

- Mike reported that Rich has expressed concern about what follow-up will be expected after pilot. Mike assured him that the pilot is only to collect data and gain understanding of logistics.
- \$5000 that we are requesting for pilot was incorrectly placed in DPW budget. We agreed by unanimous vote that at October 3 meeting with DPW and Administration, Mike and/or Peter will clarify that we do NOT want the money to come out of DPW budget.

### **Town Council Update** by Sally. (Council hasn't met since our last meeting.)

- Because of tightness of budget, it is unlikely that we will get money for pilot.
- Because of fees now collected by state Solid Waste Management Fund, grant money may become available for a pilot in 2027.

#### Planning Board Update by Paul.

- Riverwoods expansion in "holding pattern"; lot line adjustments considered.
- Housing Task Force is holding public meeting October 7 to share the recommendations they plan to make to PB and TC.

### **Town Council Presentation** regarding IWMAC activities/accomplishments in past year.

- Mike already shared list via email. Naomi will restyle with bullets to make list more readable.
- Request for more alternate members will be made at October 20 TC meeting.

**Brush Pickup** – addressing concerns expressed in anonymous email.

- Em Friedrichs spoke to suggest a trial period (1-2 years) of not picking up brush. She stated that there are many better ways to direct the money spent on brush collection
- Brush is currently chipped or burned.
- Nell noted that DPW has told us that cost of brush collection is minimal
- We agreed to table this subject until we have someone present from DPW to participate in discussion.
- Peter made a list of questions for DPW, that he will email members after meeting. Those questions are listed at end of minutes.

#### Sustainability Newsletter.

- Julie will be meeting with Todd later in day to discuss newsletter.
- We discussed two possibilities: a separate quarterly sustainability newsletter; and a new format to Friday Updates with hyperlinks to different topics, e.g. town business, recreation, sustainability.
- UNH student is still available to work on newsletter.

Chair Report by Nell about her recent discussion with Pete Lachapelle of Waste Management.

- Currently, cost of handling recyclables is approximately \$100/ton vs. approx. \$80/ton for solid waste.
- WM prefers to take only no. 1, 2, and 5 plastics.
- WM takes waste water treatment sludge, dries it, and puts it in landfill if PFAS levels are low enough.
- RMI spreads dried sludge on land. It is unclear whether DPW has considered using WM to process sludge and, if not, why not.

#### PFAS in Waste Water Treatment Plant Sludge.

- Allison fielded questions about her report at the last meeting.
- Sally suggested that we wait until DPW is present to discuss this further.

We adjourned at 9:50, purposing to meet again on October 15. At that time we can consider whether a meeting on October 29 is needed.
