Depot Road Parking Lot Regulations

I. Purpose

The Depot Road Parking Lot regulations shall govern the sale and use of permits authorizing parking in the Depot Road municipal parking lot. These regulations are administered by the Durham Police with approval of the Town Administrator.

II. Definitions

Depot Road Parking Lot: The parking lot owned and regulated by the Town of Durham, New Hampshire and located on Depot Road adjacent to the Amtrak Railroad Station.

Hours of Operation: Seven days a week, twenty-four hours a day.

Vehicle Towing: Any vehicle illegally parked in the Depot Road parking lot shall be issued a parking violation **and** then towed by authorization of a Durham Police Department employee. The Town of Durham is not responsible for damage done to vehicles towed as a result of being illegally parked.

Durham Resident: Must present a vehicle registration demonstrating the vehicle is registered in Durham, NH.

Semester: 1st Semester will be August 1 – December 31.
2nd Semester will be January 1 – May 31.

Summer: June 1 – July 31

III. Procedures

Parking permits are sold to any person or entity who desires to park in the Depot Road parking lot. All parking permits are sold on a first come/first served basis in the following categories.

Per Semester	\$625.00
Summer	\$150.00

Per Semester	\$150.00

IV. Pay and Display

A kiosk capable of dispensing a “pay and display” ticket for \$1.50 per hour or \$18.00 per day for 5 days, is located at the entrance of the Depot Road Parking lot. There will be twenty-five (25) spaces allocated for pay and display parking.

V. General Information

1. One hundred forty-six (146) permits will be sold.
2. **1st Semester permits will be valid from August 1 through December 31st. 2nd Semester permits will be valid from January 1st through May 31st and will be color coded by semester.**
3. **All permits will be sold by the Durham Police Department on our website at: www.ci.durham.nh.us/parking , on a first-come, first-served basis until depleted. The permits are non-refundable. Payments can be made with a credit card.**
4. All permit holders are required to make an account on the parking website first, before purchasing a permit. This includes: year, make, registration number and email of the vehicle using the parking lot.
5. Permits are transferable to other vehicles operated by the permit holder.
6. Permit holders may not sell or transfer permits to any other person or entity. Violation of this will result in the permit being confiscated with no refund issued.
7. Permits must be prominently hung from the rearview mirror to allow immediate viewing from outside the vehicle. If the permit is not visible, the vehicle is in violation and subject to towing.

8. So that verification of a valid parking permit can be accomplished efficiently and quickly, all vehicles shall be backed into parking spaces.
9. A permit to park in this lot does not exempt the permit-holder from any Town of Durham or University of New Hampshire parking regulations.
10. Lost, misplaced or stolen permits shall be reported to the Durham Police Department immediately. Replacement cost is \$50.00.
11. **Snow Removal:** This generally will occur during the overnight hours. You will be given advance notice of when your vehicle needs to be moved and to where. Vehicles remaining in the parking lot during the snow removal period will be towed at the owners' expense. Specific dates/times for snow removal will be determined per incident. **Please check your email as all information on snow removal will be communicated via email. Removal of their vehicle is the sole responsibility of the permit holder and no reimbursements for towing charges will be granted.**
12. The Town of Durham may revoke or suspend a parking permit or refuse to issue a parking permit without prior notice. Parking permits may be revoked, suspended, denied, or not renewed for nonpayment to the Town of Durham of parking fines, multiple violations, or by obtaining a permit by false information or selling or lending permits to others. There will be no rebates or refunds for parking permits revoked or not used.
