Hi Michael, will you please forward this to the PB? It does not need to be posted on the web site. We are concerned with Sandy Urso's letter to the PB of Nov. 30 that said we made a false statement to the PB regarding our efforts to engage the Urso family in our letter of Aug. 28 regarding the 8 CUP criteria. We stand by that letter. I count 9 emails (see below) that we sent to her seeking her input on our project, plus several voice mails to publicly available telephone numbers of her, her husband, and her son, and one chance encounter on the property. We've acted in good faith and are not making false statements to the PB or anyone else.
