On May 11, 2022, Toomerfs' engineer Mike Sievert explained that the Church Hill Woods' trees that would be removed if the parking-lot plan is approved are still shown in their only submitted "after" Photoshopped renderings because the trees in front of the old rock wall are on the abutting Andersen property and would remain even if the Church Hill Woods trees are uprooted.

Since I have permission to go on the Andersen property, and since I and others have requested for many months accurate renderings of what the proposed 2.5-story (plus lighting poles) edifice would actually look like (from adjoining properties and streets and paths, **but also from close-up**), I am providing here high-quality images of the old rock wall boundary between the Andersens' home and Toomerfs' Church Hill Woods, all with *no Andersen trees in the foreground*.
