Dear Mr. Behrendt,

I am writing in earnest support of Scott and Karen Letourneau's Tideline Public House proposal. This is an amazing opportunity for the Town of Durham.

I have lived in the Seacoast for 25 years now, originally in Portsmouth, then in Exeter and now in Durham's Faculty Neighborhood since 2009. I work full time at a law firm and have two children ages 11 and 9. I see surrounding towns embracing creative concepts to bring the community together, and I wish I didn't have to drive to Portsmouth, Kittery Foreside, Newmarket or Exeter for family-friendly gathering spaces, outdoor recreation, nature-based activities, local food and live music. As examples, we frequent Prescott Park, Lil's Bakery, Odiorne State Park, Newcastle Common, Swasey Parkway, Stone Church and The Word Barn. These are destinations where I am happy to organize families to join us to create memories, but wouldn't it be great if instead of traveling to other towns, I could rally people to come to Durham to enjoy free time, celebrate community and spend money?

We frequent many of the downtown businesses including our favorite restaurants: Big Bean, Hop & Grind, Durham House of Pizza, Ciao Italia and Libby's. We enjoy these options, but are looking forward to more dining and take-out diversity.

The proven business concept and extensive details in the Tideline Public House proposal are like a dream come true. This is unsolicited and has landed in your lap. I'm sure you are familiar with all the points, but to hit the highlights I appreciate most:

- Creating a walkable, bikeable indoor/outdoor gathering place for families, local residents, and students
- Can become a true 'destination' as a first in the region type of business, benefitting other
 Durham businesses and lodging establishments
- Trading asphalt for permeable pedestrian friendly outdoor landscape/hardscape and other commitments to sustainability
- Gathering space could be the host location for various charitable and social events

The developers have anticipated and addressed everything, including 9/10pm close to remedy the potential for late night noise. If the Town has found legitimate issues with this proposal, I would like to understand those concerns, or what alternative vision the Town has?

I have heard that the Planning Board is raising an issue over parking spaces. My understanding is that the town retained ownership of eight parking spaces in the lot behind the old town hall as overflow parking and is requiring the would be business owner to compensate the town for the value of these spaces or replace then in-kind. I have only ever seen the parking lot at the new town hall full one day per year for the annual plant sale. If overflow spaces are needed for an event at town hall there is parking along Mill Pond Road. Holding a worthwhile development proposal hostage over these spaces isn't in the interest of residents.

I also see vision statement claims that we are fostering a vibrant downtown, encouraging development that serve local needs and interests while attracting visitors from neighboring vicinities and prudently integrating our community's range of values. The developers' proposal checks all those boxes and more, and is as forward-thinking as you could dream of; "creating a special "sense of place" for present and future residents, property owners, and businesses" as quoted from the Town's mission statement.

With all of the exhausting controversy over the Plaza Development and Dam, the Town needs a win with the residents, so I encourage you to approve this as soon as possible. We will join a grassroots campaign, order signs and come to meetings if we have to, but I would rather have faith and trust that the Town Planning Board will make a wise decision for all of our sakes and give the developers a green light to move forward.

I am a professor at UNH and have spent time at my fair share of different college campuses and college towns around the country. Durham, NH lacks any significant community gathering place that brings together not only the many families of the town but also brings in the many college students together as well. College towns are a unique opportunity to blend the fraternization of the generations from child to young adult to adults while also providing business opportunities for the young adults graduating from their universities. The proposed Tideline Public House is a unique opportunity to move Durham towards this vision.

In the past decade I have lived in Miami, FL and San Diego, CA while also visiting Columbus, OH often (where my wife attended grad school). Good morning Mr. Beherendt and Mr. Selig. I write to you this morning with excitement about the recent project proposed at the site of the old town hall. This type of community gathering space is exactly what Durham needs right now and I fully support it as a citizen, neighbor (21 Durham Point Road) and experienced hospitality industry professional.

My wife and I moved to Durham 11 years ago and we love it, the only major improvement we have longed for is more variety in food and beverage offerings available here. The addition of Ciao in the last few years has been great, but generally we find more options in Newmarket, Dover and, of course, Portsmouth. It would be great for general economic development in town to have Durham be back on the map with a unique food/beverage/community focused venue that caters to a wider cross-section than simply college students.

As someone who has worked in development roles in the beer industry for 20 years and dealt directly with hospitality outlets (hotels, resorts, restaurants and event venues) I can say that this concept will offer a draw across all demographic categories.
