The Town of Durham invites qualified bidders to submit sealed bids for a new 2024 Aerial Lift, Fiberglass Body, Cab & Chassis.

Request for Bid Proposals 2024-02 is available Monday through Friday between the hours of 8 AM – 12 Noon and 12:30 PM - 4:30 PM at Durham Public Works, 100 Stone Quarry Drive, Durham NH 03824, (603) 868-5578.

All bid proposals must be submitted in a sealed envelope, clearly marked "PURCHASE OF A NEW 2024 AERIAL LIFT, FIBERGLASS BODY, CAB & CHASSIS" on or before 11:00AM (EST), Thursday March 28th, 2024 to be eligible for consideration. In the event Town Offices are closed due to inclement weather on Thursday March 28th, 2024, the due date will extend one business day to Friday March 29th, 2024.

<u>GENERAL CONDITIONS FOR BIDDING AND CONTRACTS FOR</u> <u>MATERIALS, EQUIPMENT AND SUPPLIES</u>

NATURE OF PROPOSAL AND ELIGIBILITY TO BID. The proposal is submitted in accordance with Section 5.13, Purchasing Procedure, of the Durham Town Charter and Section 10 of the Town's Purchasing Policies and Procedures manual and rules promulgated thereunder and constitutes a firm and binding offer. The determination of whether a bid proposal may be withdrawn is solely at the discretion of the Town Administrator. However, in no event shall a proposal be withdrawn unless the request for withdrawal is filed within five days of the date of the bid opening and the bidder establishes that the bid contains a material mistake and that the mistake occurred despite the exercise of reasonable care.

BIDS. Bids must be received at Durham Public Works before the date and time specified for the opening. Bids must be made on the official bid proposal and must be typed or clearly printed in ink. Corrections must be initialed. Bids are to be made less Federal Excise Tax and no charge for handling. Bids that are incomplete or unsigned will not be considered.

Bids will be made public at the time of the opening and will be reviewed, only after they have been properly recorded. Bid results will not be given by telephone and shall be given by mail only if requested in writing and accompanied by a self-addressed, stamped business size envelope.

RIGHT TO REJECT PROPOSALS AND WAIVE INFORMALITIES. The Town reserves the right to reject any or all proposals, to waive all non-material irregularities on information in any RFP and to accept or reject any item or combination of items.

SPECIFICATIONS. Vendors must bid on items as specified. **Any proposed changes must be detailed in writing and received at Durham Public Works at least five (5) working days prior to the bid opening.** Vendors shall be notified, in writing, if any changes to bid specifications are made. Verbal agreements or instructions from any source are not authorized.

BASIS OF AWARD. The award will be made to the lowest responsible base bidder meeting the specifications of this RFP unless other criteria are noted within. The award to the lowest responsible base bidder may be made by individual base bid items or a combination of base bid items and bid alternative items. The Town reserves the right to reject any or all bids or any part thereof.

Discounts will not be considered in making the award but may be offered on the invoice for earlier payment and will be applicable on the date of completion of delivery or receipt of invoice, whichever is later. On orders specifying split deliveries, discounts will apply on the basis of each delivery or receipt of invoice, whichever is later.

DELIVERY. If the vendor fails to furnish items and/or services in accordance with all requirements, including delivery, the Town may repurchase similar items and/or services from any other source without competitive bidding and the original vendor may be liable to the Town for any excess costs. If a vendor is unable to complete/deliver by the date specified, he/she must contact the using agency. However, the agency is not required to accept a delay to the original delivery date. All deliveries are subject to inspection and receiving procedure. Deliveries are not considered accepted until compliance has been established. Town personnel signatures on shipping documents shall signify only the receipt of shipment.

INVOICING. All invoices must be in duplicate showing Order Number, Unit and Extension Prices and discounts allowed. Unless otherwise noted on the proposal, payment will not be due until thirty (30) days after all services have been completed, inspected and accepted or the invoice has been received at the Business Management Department, whichever is later.

PATENT INFRINGEMENT. Any bidder who has reason to believe that any other bidder will violate a patent should such bidder be awarded the contract shall set forth in writing, prior to the date and time of bid opening, the grounds for his belief and a detailed description of the patent.

ASSIGNMENT PROVISION. The contractor/vendor hereby agrees that it will assign all causes of action that it may acquire under the antitrust laws of New Hampshire and the United States as the result of conspiracies, combinations or contracts in restraint of trade which affect the price of goods or services obtained by the Town of Durham.

TOXIC SUBSTANCES. In compliance with RSA 277-A known as the Workers Right to Know Act, the vendor shall provide Material Safety Data Sheets with the delivery of any and all products covered by said law.

SPECIFICATION COMPLIANCE. The vendor may be required to supply proof of compliance with bid specifications. When requested, the vendor must immediately supply the Business Management Department with certified test results of certificates of compliance. Where none are available, the Town may require independent laboratory testing. All costs for such testing, certified test results or certificate of compliance shall be the responsibility of the vendor.

FORM OF CONTRACT. The terms and conditions set forth on the reverse side of this form are part of the proposal and will apply to any contract awarded the bidder unless specific exceptions are taken and accepted by the Town Administrator.

I. GENERAL

It is the intent of these specifications to describe the Town of Durham's requirements for:

A 2024, New, Aerial Lift, Fiberglass Service Body, Cab & Chassis.

Furnish all manufacturers' standard equipment not in conflict with these specifications. All equipment furnished must comply with applicable State of New Hampshire and Federal laws.

1.0 WARRANTIES

All warranties for all components and workmanship will be clearly indicated in the bid(s). One (1) year, one hundred percent (100%) parts and labor, no cost warranty, is the minimum acceptable warranty. Written warranties will be required before acceptance of completed work and the beginning date of said warranties will be the date of acceptance by the Town. If a warrantable component fails during the warranty period, the bidder agrees to provide a replacement machine to the Town at no cost until a repair is completed.

2.0 OPERATOR'S MANUALS, SHOP MANUALS AND PARTS LIST

Two (2) sets of manuals and parts lists will be provided for all equipment and components before acceptance.

3.0 TRAINING

Upon delivery of the equipment, a qualified representative shall instruct Town Personnel in the operation, servicing, and lubrication of the equipment at the Durham Public Works main campus.

4.0 EXCEPTIONS TO SPECIFICATIONS

Any exceptions to specifications on any component will be clearly indicated on form provided including justification for exception. To approve an exception, it must be clearly demonstrated to the Town that it is in the Town's best overall interests to do so. The Director of Public Works' decision on all exceptions will be final.

5.0 DELIVERY

Bid price shall include delivery and mounting of the equipment, fully serviced and ready to operate to the Durham Public Works main campus at 100 Stone Quarry Drive, Durham, N.H.
