## **NOTICE OF PUBLIC HEARINGS**

### **Durham Town Council**

**Monday, October 16, 2023 at 7:00 PM:**

The Durham Town Council will hold a Public Hearing on Resolution #2023-22 authorizing the issuance of long-term bonds or notes not to exceed one million five hundred and one thousand and eight hundred dollars (\$1,501,800.00) for the purpose of bonding 2019-2023 Capital projects and equipment purchases.

The Durham Town Council will hold a Public Hearing on Resolution #2023-23 Authorizing the Acceptance and Expenditure of Funding from the National Oceanic and Atmospheric Administration (NOAA) Community-Based Restoration Program, for the Design of a Fish Passage at the Oyster River Reservoir Dam (located at the UNH/Durham Water Treatment Plant), In the Amount of up to \$290,000, and Authorize the Town Administrator to Sign and Submit Grant Paperwork on Behalf of the Town of Durham.

The Durham Town Council will hold a Public Hearing Resolution #2023-24 Authorizing the Acceptance and Expenditure of Funding from the US Fish and Wildlife Service National Fish Passage Program, for the Mill Pond Dam Removal Project, in the amount of up to \$100,000, and Authorize the Town Administrator to sign and submit grant paperwork on behalf of the Town of Durham.

The Town Council will be meeting in Council chambers. Members of the public may participate via Zoom teleconferencing or in-person.
